**Student/Parent Agreement – Contract for Services**

**General Information:** Classes will begin the week of August 15, 2011 and will continue through December 18, 2011 (only having off Greenville County's school calendar dates of Fall – Thanksgiving Break. Classes will follow the Greenville County school calendar as far as weather.

**Attendance:** Good attendance is absolutely important and necessary to receive the most from your class(es). Attendance is vital while learning your dance routines, steps, moves etc. Please help your child(ren) make it to class regularly and on time.

**Dance Wear :** Appropriate dance attire must be worn in class . Creative Movement dancers must have hair out of face, may wear any color leotard with or without an attached skirt and pink leather ballet shoes. In Pre-ballet and ballet, dancers must wear hair in a bun, pink tights, black leotard and pink leather ballet slippers – skirt is optional. In Pre-tap, tap, and Jazz dancers must have hair pulled up, skin colored tights, black leotard, or fitted top and black jazz pants, and the appropriate dance shoes. Black tap shoe (no high heel) and black split sole jazz booties. In Hip Hop dancers must have hair pulled up, fitted top, jazz or hip hop pants and appropriate shoes (shoes depend on class level). While coming and going to the studio please cover up and wear street clothes – **NO DANCE SHOES OUTSIDE, EVER!!!!!! STREET CLOTHES ARE NOT APPROPRIATE DANCE ATTIRE!!!!!!!!!!**

**Tuition:** This studio is offering a service where full payment is expected and this contract details the full tuition and other options of payment.

**Tuition is non-refundable.** Tuition may be paid using cash or check. There is a \$40.00 registration fee per student. This reserves a spot for your child for fall, winter and spring classes. **A LATE CHARGE OF \$10.00 WILL BE APPLIED IF TUITION IS NOT PAID BY THE 1<sup>ST</sup> CLASS OF THAT MONTH, AND \$10.00 FOR EVERY LATE WEEK THEREAFTER!** Also a \$30.00 charge on any returned check. All class tuition is as followed.

The first tuition payment will be due the first class of the month beginning with August. Last payment due will be the first class of the month of May. Costumes will not be released until all tuition is paid up to date the first class in December and the first class in May. 2009 – 2010 tuition schedules are based on a nine month (36 week) session. Tuition may be paid in one of the following payment plans:

1 Class	Monthly - \$45.00	Semester - \$202.50 (10%off)	Annually - \$405.00 (10%off)
2 Class	Monthly - \$81.00 (10%off)	Semester - \$405.00(10%off)	Annually - \$810.00 (10%off)
3 Class	Monthly - \$121.50(10%off)	Semester - \$607.50(10%off)	Annually - \$1215.00(10%off)
4 Class	Monthly - \$162.00(10%off)	Semester - \$810.00(10%off)	Annually - \$1620.00(10%off)

Single Classes are \$15.00 per class plus the registration fee is due on the first class.

\*Additional family members will receive an additional 10% off discount. The dancer taking the most classes will be regarded as the 1<sup>st</sup> family member. The monthly tuition is due the first class attended every month by the child(ren) regardless of how many scheduled classes your child(ren) attend(s) during the month. Your child may attend a different class to make up missed classes and to keep a perfect attendance.

**All workout/Flexibility adult classes:**

Monthly classes \$150.00 (bring a friend and receive additional discounts)

**All Irish/Salsa:** Registration Fee is \$40.00 per student

1 Class 6 Week Session - \$80.00 Semester - \$240.00 Annually - \$480.00

Single Classes are \$25.00 and the Registration fee still applies to the first class!

**Costumes :** May recital costume fees are \$55.00 per child per class for ages 8 and under and \$65.00 per child per class for ages 9 and up. Some Costumes may be priced differently depending on child's size/height and Level Costumes are given to the dancers 2 weeks before the recitals. Costume fees must be paid in full by the 1<sup>st</sup> week in October (for the December recital). Costume fees are non-refundable.

Semester accounts, costume fee's, recital fee's and late fee's must be paid in full the 1<sup>st</sup> week in December (for the December recital) before your child(ren) will receive their costume(s).

**Recital:** The May recital dates will be announced at a later date. There will be a recital fee of \$40.00 per family which is due by the first week in March for the end of the year recital. This is done instead of ticket sales, you may bring as many people as you would like to the recitals.
